While serving at Interior, Michael championed cross-agency coordination of federal water policy programs to ensure efficient implementation and the inclusion of stakeholder priorities.

Michael also spent over a decade working in senior roles at the U.S. House of Representatives. As Professional Staff for the House Energy and Water Appropriations Subcommittee, he crafted funding legislation and oversaw budgets for the U.S. Army Corps of Engineers (Corps) and Reclamation and built a bipartisan reputation working with congressional offices and stakeholders to address their needs. He also drafted authorizing legislation for the Corps and the U.S. Environmental Protection Agency as Counsel for the House Transportation and Infrastructure Subcommittee on Water Resources and Environment. In these roles he was responsible for working with Members of Congress their staff, and other stakeholders, on key policy initiatives related to national water infrastructure programs.
