Gail frequently presents on telecommunications topics to organizations such as the International Municipal Lawyers Association, National Association of Telecommunications Officers and Advisors and its regional chapters, League of California Cities and Alliance for Community Media. She was licensed but is now inactive in the Province of Ontario, Canada.
