City Attorney/General Counsel

Scott serves as the city attorney for the City of Avalon. In his role as city attorney, Scott attends City Council meetings and oversees all legal services. He also serves as general counsel for the Gold Coast Health Plan, a public entity that provides Medi-Cal services to approximately 220,000 residents of Ventura County.

He has also served as general counsel for the Lake Arrowhead Community Services District, attending board meetings, providing advice on compliance with the Brown Act and conflict of interest laws, and overseeing legal issues that arise. Scott has attended more than 1,400 Brown Act meetings during his 38 years of practice representing public agencies.

Administrative Law

Scott has served as counsel for Alhambra and Monterey Park Civil Service Commissions, where he has overseen hearings from employees who are appealing disciplinary actions. Over the last 30 years, Scott has handled over two dozen such appeals.

Litigation

Scott has tried over 30 cases ranging from unlawful detainers to civil rights matters. He has first chair experience in court and jury trials. He has also mediated numerous matters including wrongful termination, insurance coverage, breach of contract and construction defect cases.

- with LAWA on updating their contracting documents for future infrastructure projects.
- Lake Arrowhead Community Services District (LACSD): Scott advised LACSD on their recycled water plant project that established a recycled water system that has been successfully operating for a decade.

He was appointed a League Partner Policy Committee Liaison for 2020 to the Transportation, Communications and Public Works Committee.
